  - (A) Pending or contemplated litigation; or
  - (B) A settlement offer; or
- (2) On a matter in which the duty of the attorney to the governmental body under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with this chapter

- Valero vs Nueces County Appraisal District Update

**Section 551.074: Personnel Matters**

(a) This chapter does not require a governmental body to conduct on open meeting:

1. To deliberate the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of a public officer or employee; or
2. To hear a complaint or charge against an officer or employee.

(b) Subsection (a) does not apply if the officer or employee who is the subject of the deliberation ore hearing request a public hearing.
